Mr. Paredes asked about warranty of the transistor Radios

The Chair said upon delivery/receipt and inspection Transistor Radios must function. (Note: Warranty is 1 year after acceptance for non-expendable supplies (Sec. 62.1 of the RIRR of RA 9184)

Mr. Junsay from Precious Prince Ent. asked about their eligibility because they don't have an experience on Transistor radios, only printers and bond papers.

The Chair said he can join as long as transistor radios or similar equipment is included in their business permit/BIR certificate of registration.

The Chair reminded the prospective bidders that being the lowest bidder is not guarantee that they will be awarded the project. The project will awarded to the responsive bidder.

Mr. Paredes asked whether delivery period is 20 days only.

The Chair said that the BAC will stick with the 20 days delivery period as of now. The BAC will be meeting the end-users after this meeting.

The Chair advised the prospective bidders to refer their queries to BAC Secretariat.
