GENERAL AGREEMENT

OBLIGATIONS OF THE FIRST PARTY

 - (b) Responsible for the installation of content updates to the units;
 - (c) Monitor the units borrowed by the learners;

OBLIGATIONS OF THE SECOND PARTY

- 3.1 The Second Party shall, for its exclusive account, timely, properly and adequately perform the following:
 - (a) Responsible for taking good care of the tablet personal computer;
 - (b) Use the units for online classes and other related academic-purposes only; therefore, online games should not be installed in tablet PC's;
 - (c) Understand that it is a privilege and not a right to have regular access to a laptop;
