**SUBMISSION OF LIST OF ALS TEACHERS FOR THE GRANT OF SPECIAL  
HARDSHIP ALLOWANCE, CASH ALLOWANCE, TRANSPORTATION ALLOWANCE  
AND TEACHING AID**

TO: Schools Division Superintendents

1. This is in reference to Memorandum DM-OAGA-2021-0046 entitled Submission of List of ALS Teachers for the Grant of Special Hardship Allowance, Cash Allowance, Transportation Allowance and Teaching Aid.
2. The Department of Education through the ALS Task Force reiterates the grant of Special Hardship Allowance (SHA) and Cash Allowance (CA) to Teachers, pursuant to Special Provisions 10 and 11 of the General Appropriations Act for FY 2021 (GAA FY 2021) and the grant of Transportation Allowance and Teaching Aid for Alternative Learning System (ALS) Teachers and Community ALS Implementers, pursuant to Special Provision 21 of GAA FY 2021. Moreover, the grant of the former is also stipulated in Section 22 of the ALS Act (RA 11510), enacted on December 23, 2020.
3. However, President Rodrigo Roa Duterte's Veto Message on Special Provision 21 of GAA FY 2021, dated December 28, 2020, imposed a conditional implementation on the grant of transportation allowance and teaching aid, which shall be subjected to the guidelines issued by the Department of Education in coordination with the Department of Budget and Management (DBM), in conformity with existing laws, rules and regulations.
4. Upon consultation with the DBM, in compliance to the President's Veto Message in 2021 GAA, the grant of the said allowances to ALS teachers shall be allowed as long as DepEd can guarantee that there shall be no double compensation. It was recommended that the ALS teachers shall either choose to receive SHA and CA or Transportation Allowance and Teaching Aid.

In relation to this, this office is requesting the Division ALS Focal Persons to submit to the regional office the list (see attachment 1 of DM-OAGA-2021-0046 ) of ALS teachers in their respective schools division offices, signifying which allowance shall be accorded to them. The said list must be duly signed by the schools division superintendent.
6. All division ALS focal persons must submit the list to the Regional ALS Coordinator through his email: [peter.angug@deped.gov.ph](mailto:peter.angug@deped.gov.ph) on or before April 26, 2021.
- The list submitted to the region and the Office of the Assistant Secretary for ALS shall be valid for one (1) year and shall be the basis of ALS Task Force in computing the Transportation Allowance and Teaching Aid for FY 2021.
  - The list shall be submitted by the ALS Task Force to the BHRD – School Effectiveness Division as basis for granting SHA.
7. To help in the decision-making of our ALS teachers, please refer to the table on pages 3-4 of OM-OAGA-2021-0046 that is attached in this Memorandum.
8. **Furthermore, all division ALS focal persons are enjoined to attend a meeting with the Regional ALS focal person on April 20, 2021 at 1:00 PM.**
