# CONDUCT OF SCHOOL-BASED FEEDING PROGRAM (SBFP) EVALUATION AND FEEDBACK SURVEY

TO: Schools Division Superintendents

- 1. As per the memorandum from the Department of Education-Bureau of Learner Support Services through the School Health Division (SHD) there shall be the conduct of an Evaluation and Feedback Survey (EFS) on the School-Based Feeding Program (SBFP) which aims to gather feedback from the parents and/or guardians of the beneficiaries and the field implementers on the implementation of SBFP for SY 2020-2021 and their perceived benefits to the program recipients.
- 2. The objectives of the School-Based Feeding Program Evaluation and Feedback Survey are to:
  - a) Obtain the parents'/guardians' perception on the effects of the program to the beneficiaries who received Nutritious Food Products (NFP) and Fresh/Sterilized Milk;
  - b) Gather the school feeding coordinators' feedback on the management and the implementation of the program;
  - c) Gather the parents'/guardians' satisfaction/acceptance of the program
  - d) Identify the issues and concerns that may be associated with the implementation of the program; and
  - e) Identify areas for improvement and recommend action plans.
- 3. There will be two sets of questionnaires, one intended for the parents and/or guardians, and another one for the school feeding coordinators of recipient schools. These surveys are thru Google Forms, and can be accessed through the following link:
