OPLAN KALUSUGAN SA DEPED (OK SA DEPED) NATIONAL KICK-OFF AND LAUNCH OF HEALTHY LEARNING INSTITUTIONS (HLI)

To: Schools Division Superintendents

- 1. The Department of Education through the Bureau of Learner Support Services-School Health Division (BLSS-SHD), provides updated information on the conduct of the **National Kickoff of Oplan Kalusugan sa DepEd (Ok sa DepEd)** as first communicated through the OUGFO Memorandum No. 2022-03-024 titled Strengthening School Health Support for SY 2022-2023.

- 3. The National kickoff shall serve as the venue to provide updates and directions on the implementation of OK sa DepEd for the school year as well as to show case the selected practices of the regions as well as partnership opportunities for school health .
- 4.
