# WORKSHOP ON THE PREPARATION AND CONSOLIDATION OF BAR-1 QUARTER 3 AND ORIENTATION ON BASIC EDUCATION MONITORING & EVALUATION FRAMEWORK (BEMEF)

To: Schools Division Superintendents

- 1. To ensure that the agency's plans, policies, systems and processes are geared towards the achievement of organizational and learner outcomes, DepEd SOCCSKSARGEN shall facilitate the workshop on the preparation and consolidation of Budget Accountability Report (BAR)-1 for the 3<sup>rd</sup> Quarter at the same time conduct an orientation on Basic Education Monitoring & Evaluation Framework (BEMEF) on **October 13-14, 2022 within Kidapawan City**.
