4. Division Kindergarten Coordinators are advised to prepare a 10-minute presentation that covers the following scope and number of slides:
  - 4.a Slides 1 to 3: Present the Kindergarten implementation plan focusing on physical and financial targets versus accomplishment as of September 2022 (3<sup>rd</sup> quarter);
  - 4.b Slide 4 – Highlight the facilitating factors contributing to the achievement of the targets & discuss the hindering factors that includes the bottlenecks and barriers during the implementation.
  - 4.c Slide 5 – Issues and concerns needing decision by the RO and CO;
  - 4.d Slides 6-8 Plans for SY 2022-2023 including kindergarten learning recovery plan; and
  - 4.e Slide 9 – Next steps and ways forward.
