STRENGTHENING SCHOOL READINESS AND CAPACITY OF SCHOOLS IN SPECIAL CURRICULAR PROGRAMS IMPLEMENTATION

To: Schools Division Superintendents

- 1. Pursuant to DepEd Order No. 021, s. 2019 titled Policy Guidelines on the K to 12 Education Program, the Regional Office hereby reiterates its strong commitment to the quality implementation of the following Special Curricular Program (SCP):
 - a. Special Program in the Arts (SPA)
 - b. Special Program in Foreign Language (SPFL)
 - c. Special Program in Journalism (SPJ)
 - d. Special Program in Sports (SPS)
 - e. Special Science Elementary School (SSES)
 - f. Science, Technology and Engineering (STE) Program
 - g. Special Program in Technical-Vocational Education (SPTVE)
- 2. The Office's Learning Recovery and Continuity Plan (LRCP) focuses on addressing learning gaps brought about by the pandemic, on attaining quality learning and on improving learning outcomes, hence, schools division offices and schools are directed to **temporarily suspend the preparation of applications for SCP** and instead focus on delivery of quality instruction and implementation of LRCP. This shall also provide SDOs and schools with ample time to strengthen readiness and capacity on the quality implementation of any of the special curricular programs.
- 3. Education program supervisors managing the SCP are enjoined to coordinate and collaborate with the regional focal person for technical assistance and management support in ensuring readiness and capacity of schools on facilities, learning resources and equipment including learning and development interventions for teachers who are involved in their implementation.
