REGION MEMORANDUM CLMD No. 331, s. 2022

ENHANCEMENT SEMINAR ON THE EFFECTIVE IMPLEMENTATION OF GUIDANCE AND COUNSELING PROGRAM

To: Schools Division Superintendents

1. To strengthen the implementation of Guidance and Counseling Program and Services in the region, DepEd SOCCSKSARGEN thru the Curriculum and Learning Management Division will conduct an Enhancement Seminar on the Effective Implementation of Guidance and Counseling Program on **November 4-5, 2022** in Koronadal City. The specific venue of the aforementioned activity will be announced thru a separate issuance.

- 2. The seminar specifically aims to :
 - a. discuss the roles and responsibilities of RGCs to DepEd MHPSS ;
 - b. enhance professional competence in handling counseling programs and other services; and
 - c. sustain the provision of basic support services for learners.

6. Meals , accommodation , supplies and other incidental expenses shall be charged against Region MOOE while travel and other expenses shall be charged to division or school MOOE subject to the usual accounting rules and regulations.

Teaching and non-teaching personnel attending the seminar will be entitled to service credits pursuant to Department of Education Memorandum No.67, s. 2021 on the Amendment to Department of Education No. 65, s.2021 (Clarificatory Guidelines on the Grant of Vacation Service Credits to Teachers for School Year 2020-2021 in Light of the Covid 19 Pandemic) and Compensatory Time-Off (CTO) per CSC -DBM
