**TECHNICAL ASSISTANCE TO SCHOOLS IN THE IMPLEMENTATION  
OF FILIPINO AND ENGLISH CURRICULUM**

To: Schools Division Superintendents

1. To strengthen and improve the implementation of Filipino and English Curriculum in the region, technical assistance shall be provided to schools from October 20 to November 25, 2022.
2. The activity aims to:
  - a. Monitor schools in terms of compliance to policies on DLP/DLL preparation, and learning assessment
  - b. Gather feedback on the use of “open-time” for reading remediation
  - c. Gather data on the availability of learning materials in Filipino and English Curriculum
  - d. Provide technical assistance support on learning literacy interventions for SPED implementing schools
  - e. Provide technical assistance and support to address issues and concerns in English and Filipino Curriculum
3. The template for monitoring is provided in Enclosure 1.
4. The regional EPS In-Charge of Filipino and English Curriculum shall coordinate with the division focals for the schedule of the visit.
5. Travel and other incidental expenses shall be charged to SPED Program Support Fund (PSF) subject to the existing accounting and auditing rules and regulations.
