Definition of Terms:

Proper Kitchen Facility - Kitchen within the school which may be the same as the one used in the canteen service or HE Classes and may also be devoted to prepare and cook the food for the SBFP beneficiaries.

Minimum requirements for a proper kitchen facility:

- Enough space to properly prepare and produce the food
- Must have sufficient, basic kitchen equipment (i.e., stove, pots/casseroles/vats, ladles, utility bowls and plates, knives, spoon, and fork, chopping board, etc.) in good working order
- Must have potable water supply
- Must have a countertops or table that is in good condition and easy to clean
- Must have proper storage for dry goods and fresh produce
- Must have a refrigerator or freezer to store the meat, poultry, or other produce that need to be refrigerated.
- Must have a sink to be used for handwashing and cleaning all the dishes and cooking equipment
- Must have proper ventilation to circulate air

Minimum requirement proper feeding area/room - a specific feeding room area or building permanently dedicated for the beneficiaries of SBFP.

Minimum requirement for a Proper Feeding Area/Room

- Must have sufficient tables and chairs for all the beneficiaries
- Must have proper lighting and ventilation
- Must have IEC materials posted on the wall
