REGION MEMORANDUM

QAD No. 44, s. 2022

**PROFILING OF LEARNING DELIVERY MODALITIES TO BE IMPLEMENTED IN
PRIVATE SCHOOLS BEGINNING NOVEMBER 2, 2022**

To: Schools Division Superintendents

1. Pursuant to DepEd Order No. 044, s. 2022: Amendment to DepEd Order 34, s. 2022 (School Calendar and Activities for the School Year 2022-2023), private schools are given the option to continue to implement the learning modality they identified at the start of SY 2022-2023.

2. To reiterate, item #16 of DepEd Order 034, s. 2022 that directly affects private schools is amended as follows:

#16. *Private schools may continue to implement any of the following options:*

- a. 5 days of in-person classes;
- b. Blended Learning Modality
 - b.1 three days of in-person classes and two days of distance learning (modular, online or television/radio-based instruction); and thereafter, four days of in-person classes and one day of distance learning (modular, online or television/radio-based instruction)
- c. Full Distance Learning

3. Relative to this, the regional office through the Quality Assurance Division (QAD) shall be conducting an inventory or profiling of the learning delivery modalities that private schools will be implementing starting November 2, 2022 onwards, for purposes of monitoring and technical assistance.

4. All private schools are requested to accomplish on or before November 4, 2022 the google form that can be accessed through the link **tinyurl.com/LDMPSch2022**.

5. SDOs through the private school coordinators are likewise advised to monitor the submission and implementation of the adopted learning delivery modalities of private schools.
