**PARTICIPANTS FOR THE EVALUATION OF EXISTING DEPED READING
PROGRAMS: CONFERENCE WITH REGIONAL OFFICES
AND SCHOOLS DIVISION OFFICES**

To: Schools Division Superintendents

1. In reference to the unnumbered DepEd Memorandum re **Evaluation of the Existing DepEd Reading Programs: Conference with Regional Offices and School Division Offices** dated November 2, 2022, the National Reading Program Technical Working Group and Bureau of Curriculum Development will hold a **National Conference on November 7-11, 2022 at Red Hotel, Cubao, Quezon City.**
2. Specifically, the conference aims to:
 - a. identify all reading programs implemented across all governance levels;
 - b. identify best practices and challenges in the implementation of reading programs;
 - c. gather data on learners' reading proficiency;
 - d. craft a framework for the National Reading Program; and
 - e. draft the implementing guidelines of the National Reading Program.
3. Participants in the said activity are the Regional and Division Reading Coordinators listed in the enclosure.
4. Identified participants are tasked to prepare an analysis and interpretation of the data gathered using the National Reading Program Survey Tool disseminated through **Region Memorandum No.372, s.2022.**
5. All expenses relative to the conduct of the activity including board and lodging, and travel expenses shall be charged against FLO fund subject to the usual government accounting and auditing procedures. In case the downloaded funds are not sufficient to cover the actual expenses incurred, the local funds shall be utilized to augment the reimbursement of the said expenses.
