WHEREAS, the office of the SGOD-DRRM of the Department of Education, Schools Division of South Cotabato requested for the procurement of **Lease of venue with meals, snacks and accommodation for the conduct of DRRM Program Mid-Year Implementation Review and Plan Adjustment on July 11-12, 2022** (DSC-22-05-082) with the approved budget for the contract (ABC) amounting to **Ninety-Two Thousand Five Hundred Pesos (Php 92,500.00)**;

WHEREAS, the Schools Division Superintendent approved the conduct of such activity which requires leasing of venue including accommodation, meals and snacks;

WHEREAS, Section 53.10 of the Revised implementing Rules and Regulations (IRR) of RA 9184 allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue for official use;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat invited three (3) hotels/venues of known qualifications to submit quotation;

WHEREAS, the BAC received only one (1) quotation and opened the same on June 21, 2022 1:00 pm;

WHEREAS, the BAC, upon careful deliberation and evaluation of the submitted price quotation, found the offer of **Isla Jardin Del Mar** as the single calculated and responsive quotation detailed as follows;




