**WHEREAS**, the office of the **SGOD-Health** of the Department of Education, Schools Division of South Cotabato requested for the procurement of **Lease of Venue with Meals and Snacks for the conduct of Orientation and Workshop on the implementation of comprehensive sexuality Education ((Adolescent Reproductive Health) ARH) on July 14-15, 2022** (DSC-22-07-141) with the approved budget for the contract (ABC) amounting to **Sixty-Three Thousand Eight Hundred Pesos (Php 63,800.00)**;

**WHEREAS**, the Schools Division Superintendent approved the conduct of such activity which requires leasing of venue including meals and snacks;
