WHEREAS, the SGOD-SHS - Schools Division of South Cotabato requested for the procurement of **Supply and Delivery of Pasteurized Milk for the School-Based Feeding Program (SBFP)** (DSC-22-08-177) with the approved budget for the contract (ABC) amounting to **One Million Seven Hundred Fifty-Seven Thousand Two Hundred Twenty-Nine Pesos and Forty-Four Centavos (Php 1,757,229.44)**;

WHEREAS, on **August 8, 2022**, the BAC, after due deliberation of the submitted purchase request and the attached documents, passed Resolution no. 2022-08-059 - Recommending the Alternative Method of Procurement-Negotiated Procurement- Agency-to-Agency for the procurement of Pasteurized Milk;

WHEREAS, the BAC, thru its Secretariat, prepared and sent a request for quotation to **National Dairy Authority (NDA)** as the servicing agency for the project;

WHEREAS, the BAC, upon careful deliberation and evaluation of the documents and price quotation, the Bids and Awards Committee agreed to recommend award of the contract to **National Dairy Authority (NDA)** as the servicing agency that can fully and legally support the implementation of the School-Based Feeding Program-Milk Feeding Program Component;

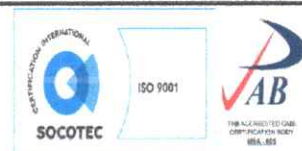
WHEREFORE, premises considered and upon the unanimous sponsorship by the BAC members let it be;
