WHEREAS, the SGOD-SHS office of the Department of Education, Schools Division of South Cotabato advertised the Invitation To Bid (ITB) for the **Supply and Delivery of Nutritious Food Products (Implementation of School-Based Feeding Program (SBFP) of FY 2022) (DSC-22-08-179/8907876)** with an approved budget for the contract (ABC) amounting to **Six Million Seven Hundred Sixty-Nine Thousand Eight Hundred Seventy-Two Pesos (Php 6,769,872.00)**;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat posted at the websites of the Philippine Government Electronic Procurement System (PhilGEPS) and the DepEd-Schools Division of South Cotabato on August 12, 2022 and posted the same at the conspicuous place within the premises of the Schools Division Office of South Cotabato;

WHEREAS, the BAC issued supplemental bid bulletin thru its secretariat to schedule the opening and submission of bids on August 30, 2022 due to the declaration of National Hero's Holiday on August 29, 2022 and to require additional requirement in the Checklist of ITB that bidders must submit the accreditation certificate or any other proof issued from DOST-FNRI which will be included in the technical documents;

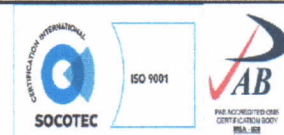
WHEREAS, in response to the said advertisements, two (2) bidders purchased the bidding documents;

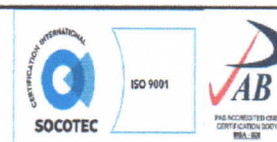
NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:
