WHEREAS, the **CID Office** of the Department of Education, Schools Division of South Cotabato requested for the procurement of **Lease of Venue with Meals and Snacks for the conduct of Roll-Out Division Training in Basic Music Concepts for Grade 1, 2 & 3 Teachers on May 4-5, 2022 (Live-out)** (DSC-22-03-034) with the approved budget for the contract (ABC) amounting to **One Hundred Nine Thousand Pesos (Php 109,000.00)**;

WHEREAS, the Schools Division Superintendent approved the conduct of such activity which requires leasing of venue including meals and snacks;

WHEREAS, Section 53.10 of the Revised implementing Rules and Regulations (IRR) of RA 9184 allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue for official use;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat invited three (3) hotels/venues of known qualifications to submit quotations;

WHEREAS, the BAC received only three (3) quotation and opened the same on March 31, 2022 10:00 am;

WHEREAS, the BAC, upon careful deliberation and evaluation of the submitted price quotation, found the offer of **Villa Princessita Catering Services** as the single calculated and responsive quotation detailed as follows;


