WHEREAS, the **CID-ALIVE** of the Department of Education, Schools Division of South Cotabato requested for the procurement of **Lease of Venue with meals, snacks and accommodation for the conduct of Orientation of the newly hired ALIVE Tahdiriya Kindergarten Teachers on September 29-30, 2022** (DSC-22-09-220) with the approved budget for the contract (ABC) amounting to **Ninety-Six Thousand Seven Hundred Fifty Pesos (Php 96,750.00)**;

WHEREAS, the Schools Division Superintendent approved the conduct of such activity which requires leasing of venue including meals and snacks;

WHEREAS, Section 53.10 of the Revised implementing Rules and Regulations (IRR) of RA 9184 allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue for official use;

WHEREAS, the BAC received three (3) quotations and opened the same on September 26, 2022, 1:00 pm;
