WHEREAS, the Department of Education, Schools Division of South Cotabato requested for the procurement of **Lease of Venue with Meals, Snacks and Accommodation for the conduct of Hosting of Regional IPEd Conference on December 12-14, 2022** (DSC-22-11-240) with the approved budget for the contract (ABC) amounting to **Sixty-Eight Thousand Two Hundred Fifty Pesos (Php 68,250.00)**;

WHEREAS, the Schools Division Superintendent approved the purchase request on November 7, 2022 to conduct of such activity which requires leasing of venue including meals and accommodation;

WHEREAS, Section 53.10 of the Revised implementing Rules and Regulations (IRR) of RA 9184 allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue for official use;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat invited three (3) hotels/venues of known qualifications to submit quotations;

WHEREAS, the BAC received only one (1) quotation and opened the same on November 18, 2022, 1:00 pm;

WHEREAS, the BAC, upon careful deliberation and evaluation of the submitted price quotation, only **Tropicana Worldwide Corporation (Dolores Tropicana Resort)** has found eligible and complying with the requirements as the single calculated and responsive quotation detailed as follows;
