WHEREAS, the OSDS office of the Department of Education, Schools Division of South Cotabato requested for the procurement of **Lease of Venue with Meal and Snacks for the conduct of 2022 4th Quarter Division Management Committee (DMANCOM) Meeting on November 11, 2022** (DSC-22-11-243) with the approved budget for the contract (ABC) amounting to **Three Hundred Forty-One Thousand One Hundred Pesos (Php 341,100.00)**;

WHEREAS, the Schools Division Superintendent approved the conduct of such activity which requires leasing of venue including meals, snacks and accommodation;

WHEREAS, Section 53.10 of the Revised implementing Rules and Regulations (IRR) of RA 9184 allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue for official use;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat invited three (3) hotels/venues of known qualifications to submit quotations;

WHEREAS, the BAC received only one (1) quotation and opened the same on November 7, 2022, 1:00 pm;

WHEREAS, the BAC, upon careful deliberation and evaluation of the submitted price quotation, found the offer of **The Farm at Carpenter Hill, Inc.** as the single calculated and responsive quotation detailed as follows;
