WHEREAS, the Department of Education, Schools Division of South Cotabato requested for the procurement of **Lease of Venue with Decoration, Meals, Snacks and Accommodation for the Conduct of Dreamweavers Awarding Ceremony on March 29, 2022** (DSC-22-03-038) with the approved budget for the contract (ABC) amounting to **One Hundred Nine Thousand Three Hundred Ten Pesos (Php 109,310.00)**;

WHEREAS, the Schools Division Superintendent approved the conduct of such activity which requires leasing of venue including meals and snacks;

WHEREAS, Section 53.10 of the Revised implementing Rules and Regulations (IRR) of RA 9184 allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue for official use;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat invited three (3) hotels/venues of known qualifications to submit quotations;

WHEREAS, the BAC received only one (1) quotation and opened the same on March 25, 2022 1:00 pm;

WHEREAS, the BAC, upon careful deliberation and evaluation of the submitted price quotation, found the offer of **The Farm at Carpenter Hill, Inc.** as the single calculated and responsive quotation detailed as follows;

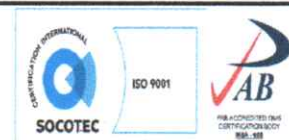
