WHEREAS, the Department of Education, Schools Division of South Cotabato requested for the procurement of **Lease of Venue with Meals, Snacks and Accommodation for the conduct of Work Organization Efficiency cum conduct of performance Monitoring and coaching of clustered AOII's on November 21-22, 2022 (Live-In)** (DSC-22-11-254) with the approved budget for the contract (ABC) amounting to **Two Hundred Forty-Nine Thousand Pesos (Php 249,000.00)**;

WHEREAS, the Schools Division Superintendent approved the conduct of such activity on October 18, 2022 which requires leasing of venue including meals and snacks;

WHEREAS, Section 53.10 of the Revised implementing Rules and Regulations (IRR) of RA 9184 allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue for official use;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat invited three (3) hotels/venues of known qualifications to submit quotations;

WHEREAS, the BAC received only one (1) quotation and opened the same on November 18, 10:00 am;

WHEREAS, the BAC, upon careful deliberation and evaluation of the submitted price quotation, found the offer of **Gensan Greenleaf Hotel and Development Corporation** as the single calculated and responsive quotation detailed as follows;
