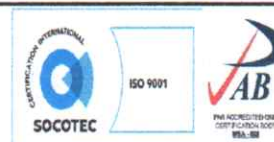
WHEREFORE, premises considered and upon the unanimous sponsorship by the BAC members let it be;




