**REGIONAL MONITORING AND PROVISION OF TECHNICAL ASSISTANCE
ON THE IMPLEMENTATION OF VARIOUS PROGRAMS, PROJECTS
AND ACTIVITIES (PPAs)**

To: Schools Division Superintendents

1. Relative to DepEd Order No. 029, s. 2022 titled Adoption of Basic Education Monitoring and Evaluation Framework (BEMEF), the Curriculum and Learning Management Division (CLMD) shall conduct regional monitoring and provision of technical assistance on the implementation of various programs, projects, and activities (PPAs) in schools and community learning centers across eight (8) Schools Division Offices. These CLMD-led monitoring activities shall be scheduled every month from **January to June 2023**.

2. The regional monitoring and TA support to SDOs and schools shall be conducted purposely to:

- a) monitor the implementation of various PPAs and validate how policy guidelines for each of these PPAs are carried out or translated into action at the SDO and school levels;
- b) provide technical assistance to SDOs and schools in implementing the PPAs policy guidelines and SDO or School Learning Recovery and Continuity Plans (LRCP); and
- c) provide guidance and support to address the issues and concerns of SDOs and schools on the following:
 - Curriculum and learning delivery (class programming, classroom instruction and assessment, classroom management, learning environment)
 - Learning remediation and intervention
 - Implementation of ALS, ADM/Distance Learning, SHS, MEP/ALIVE, IPEd, SPED, and Special Curricular Programs
 - Utilization of text based and non-text based learning resources
 - Implementation and operation of school libraries
 - Learning and Development (L&D) activities to improve teaching and learning
 - Initiatives and innovations
