- a. Community Mapping/Stakeholder engagements;
  - b. Conduct of pre-program assessment and enrolment;
  - c. Implementation of the ALS K to 12 Basic Education Curriculum (BEC);
  - d. Adoption of community-based teaching and learning strategies;
  - e. Management of learners with unique circumstances, i.e in special cases, working students etc;
  - f. Development of learning materials across the learning levels;
  - g. Development and assessment of presentation portfolio;
  - h. Preparation for the accreditation and equivalency test (A&E);
  - i. Support to learners in difficult situations i.e GIDA, financial, psychological etc;
  - j. Support to teachers related to portfolio development, project-based learning, research, material development, curriculum implementation/integration; and
  - k. Other ALS good practices not specified in the list.
5. As evidence, the Division Team must display any of the following:
- a. Documentation of the detailed processes used;
  - b. Manipulatives/demonstration materials used by teachers; and
  - c. Students' outputs, posters, and video materials/resources.
6. Arrival in the venue should be on January 17, 2023 and return to station is on January 21, 2023.
