**REGIONAL VALIDATION OF THE CULTURAL HERITAGE LEARNING CENTERS**

To: Schools Division Superintendents

1. Relative to Region Memorandum CLMD No. 153, s. 2021 re Establishment of Cultural Heritage Learning Centers (CHLC), DepEd SOCCSKSARGEN Regional Office shall conduct an on-site validation of the two IPEd Program implementing schools from South Cotabato intending to establish and operationalize the CHLC on February 10, 2023.
