1. With reference to Memorandum DM-OUHROD-2023 re 2023 HRD Program Support Fund (PSF) and INSET Fund for the Regions and Divisions, this office informs all schools division offices that these funds have been approved for direct release by the Department of Budget and Management (DBM).

On the other hand, the INSET Fund may be utilized for the Programs, Activities, and Projects (PAPs), giving priority to Literacy-Numeracy programs subject to DepEd Order No. 030, s. 2021 re Multi-Year Implementing Guidelines on the Allocation and Utilization of the Human Resource Development Fund for Teachers and School Leaders.
