VALIDATION OF SCHOOL SITES FOR SURVEY AND TITLING IN FY 2023 AND MONITORING OF SURVEY AND TITLING OF SCHOOL SITES IN FY 2019-2021

To: Schools Division Superintendents School Sites Titling Focal Persons All Others Concerned

- 1. Pursuant to the enclosed memorandum from the Office of the Legal Affairs pertaining to the validation for survey and titling of school sites for FY 2023 and monitoring of the survey and titling of school sites in FY 2019-2021 for Schools Division Offices (SDOs) with downloaded funds for survey and titling, all SDOs are directed to identify the untitled school sites in their area that will qualify for survey and titling.
- 2. In preparation for the survey and titling of the untitled school sites, concerned SDOs shall start consolidating the following documentary requirements:
 - a. Copy of notarized Deed of Donation
 - b. Original copy of owner's duplicate of OCT/TCT, if donated property is a titled property
 - c. Copy of Approved Survey Plan
 - d. Certified true copy of Tax Declaration
 - e. Certificate of no tax delinquency
 - f. Transfer tax
 - g. BIR clearance
 - h. DAR clearance (if agricultural land/camotal land)
- 3. The above-stated documentary requirements together with a) Request for Funds for the Survey and Titling of School Sites for FY 2023; and b) the Accomplishment Reports for the Financial and Physical Utilization of the downloaded funds for the survey and titling of school sites for FY 2019-2021, shall be submitted to rol2.legal@deped.gov.ph not later than March 31, 2023 in preparation for the regional visit on April 12, 2023 of the representative/s from the Sites Titling Office who will conduct the said validation and monitoring of school sites for survey and titling of this region.
- 4. All division lawyers and School Sites Titling focal persons are enjoined to attend the said validation and monitoring on April 12, 2023 in Koronadal City, with the venue to be announced later.

The Legal Affairs Strand through the Sites Titling Office (STO) will conduct a validation for survey and titling of school sites for FY 2023 and monitoring of the survey and titling of school sites in FY 2019 – 2021 for Schools Division Offices (SDOs) downloaded with funds for survey and titling.
