**IMPLEMENTATION OF THE BASIC EDUCATION MONITORING AND
EVALUATION FRAMEWORK (BEMEF) AT SOCCSKSARGEN REGION**

To: Schools Division Superintendents
All Other Personnel Concerned

1. DepEd Order No. 29, s. 2022 or the Adoption of Basic Education Monitoring and Evaluation Framework (BEMEF) issues the policy in order to guide DepEd operating units across governance levels in the conduct of monitoring & evaluation (M&E).
2. The framework specifically aims to achieve the following:
 - a. Ensure that the agency's plans, policies, systems and processes are geared toward the achievement of organizational and learner outcomes;
 - b. Set the performance measures of the agency where all operating units are expected to contribute;
 - c. Guide DepEd bureaus, services, regional and schools division offices, schools and learning centers in developing their respective M&E plans;
 - d. Define the roles and responsibilities of DepEd operating units in the M&E system and processes
3. Pursuant to this order, DepEd SOCCSKSARGEN Region, after having cascaded the policy framework to the SDOs, shall ensure the effective, efficient and inclusive implementation of all education policies and programs and the achievement of desired outcomes. The regional M&E system shall provide the regional policy makers and implementers with timely and appropriate feedback on the implementation of DepEd policies, programs and delivery systems.
4. For an effective and efficient implementation of the BEMEF in the region, this office has contextualized the framework to integrate all existing monitoring and evaluation activities at the regional and SDO levels and to guide all responsible offices in formulating their respective M&E plans. See Enclosure 1 for the DepEd SOCCSKSARGEN M&E Framework, for reference.
5. With the regional director as the over-all lead for the M&E system at the regional level, the Quality Assurance Division (QAD) takes charge in implementing it while at the SDO level, the schools division superintendent takes the lead and the SGOD ensures its implementation. **All operating units at both the regional and**

division levels are the responsible offices in the implementation of the M&E system.

6. The M&E system at the schools division office and school levels shall likewise be implemented based on their respective objectives and mechanisms specified in DO 29, s. 2022.

7. Hence, to ensure that the SDO and the schools shall implement the system across their levels, the SGOD-SM M&E shall accomplish the BEMEF Implementation Plan as agreed during the Orientation Workshop on BEMEF held last January 5-6, 2023 and to submit it to QAD thru qad.region12@deped.gov.ph on or before February 17, 2023. Enclosure 2: BEMEF Implementation Plan template is likewise attached for use by the SDO personnel concerned.

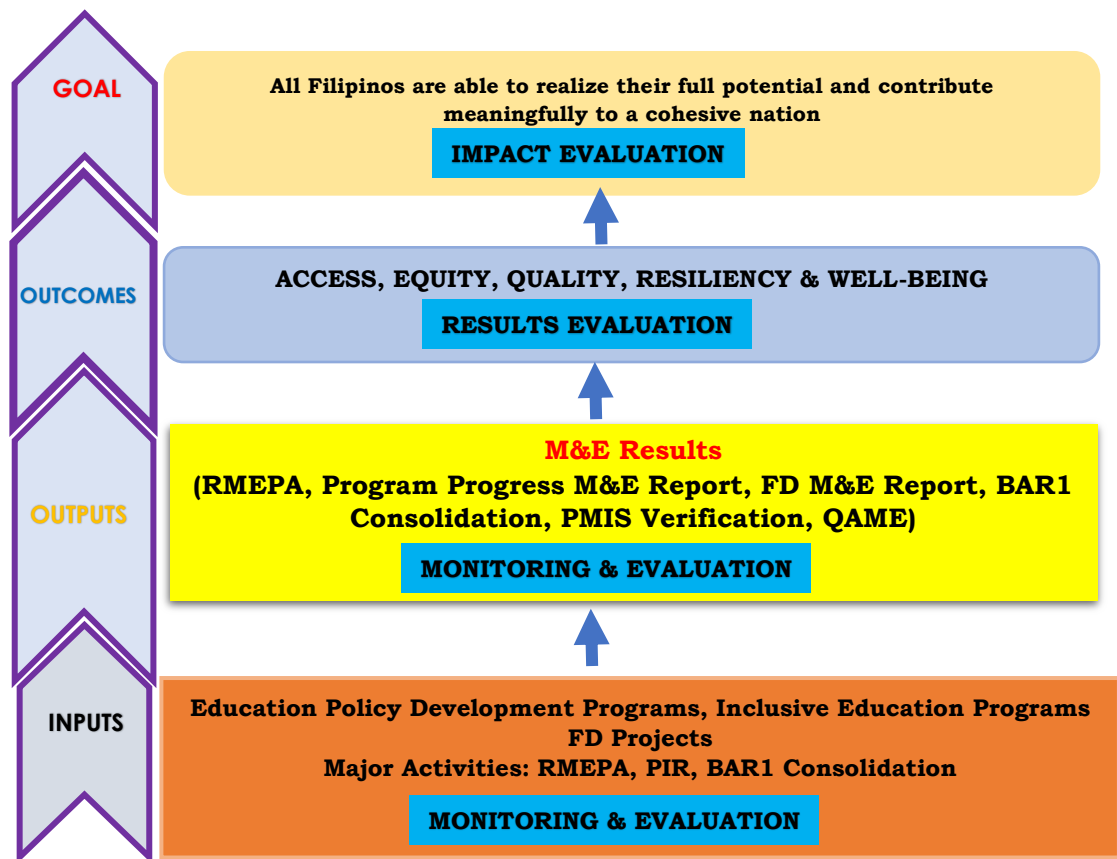
