SURVEY ON THE REVISION OF SCHOOL REDISTRICTING POLICY

To: Schools Division Superintendents
SGOD Chiefs

1. DepEd Memorandum No. 057, s. 2021 titled **Moratorium on the Request for School Redistricting and Schools Division Reclassification**, due to the piece meal requests on the creation of new districts within a division underscored that *“all redistricting requests...shall be put on hold until an updated policy and guidelines related to school redistricting shall have been issued. Likewise, requests for SDO size reclassification shall also be held in abeyance...”*
2. Initiatives have already been made with regard to the issuance of an updated policy such as creation of a technical working group, data gathering on existing guidelines, review and revision of job descriptions of related teaching positions at the regional and division offices.
3. Relative to this, as per DM-OUHROD-2023-0132, DepEd-BHROD will be conducting an online **Survey on the Revision of School Redistricting Standards** which intends to gather evidence-based data from target respondents from the region, schools division offices and schools/learning centers.
- 4. Target respondents for the survey are school heads, teachers and non-teaching staff from schools/learning centers. Personnel from the regional and division offices who interact with schools are also encouraged to answer the survey to provide feedback on technical assistance, school visits, and monitoring and evaluation activities carried out at the school level.**
5. The online survey questionnaire can be accessed starting January 30 until February 15, 2023 through the link **bit.ly/ReDistrictingSurvey2023**
6. All responses and information that will be gathered shall be treated with confidentiality in compliance with the Data Privacy Act of 2012.
