1. In reference to **Division Memorandum CID No. 030, s. 2023** dated March 07, 2023 on the **2023 Division Schools Press Conference**, all winning campus writers and their coaches shall have an **Enhancement Training** on **March 31- April 2, 2023**.
2. The Enhancement Training shall be held at **Sto. Nino National High School, Sto. Nino, South Cotabato**.
3. This training aims to:
  - a. enhance the journalistic skills of qualifiers before the conduct of higher competitions;
  - b. give them avenue to learn more techniques through the cliniquing activities; and
  - c. provide avenue for campus writers and their School Paper Advisers to mentally and psychologically prepare for the RSPC and higher journalism competitions.
4. All participants who wish to stay at the venue are enjoined to bring their own sets of bedding.
5. DepEd personnel who are involved in the activity shall be given service credits as stated in DO 53, s. 2003 titled Updated Guidelines on the Grant of Vacation Service Credits to Teachers.
