**FINALIZATION OF LEARNING RESOURCE PACKAGE (LRPs) FOR RECOGNITION
BY THE NATIONAL EDUCATORS' ACADEMY OF THE PHILIPPINES
(NEAP-QAD)**

To: All Schools Division Superintendents

1. In line with Region Memorandum HRDD No. 105, s. 2022 re: **Writershop and Evaluation of Learning Resource Packages (LRPs) of Professional Development Programs/Courses for Teachers and School Leaders**, the National Educators Academy of the Philippines (NEAP) XII shall conduct the **Finalization of the LRPs on March 24-26, 2023, the venue is within Koronadal City to be announced later in a separate issuance.**
2. The activity intends to finalize the developed and quality-assured Learning Resource Packages (LRPs) of professional development courses/programs to be given to teachers and school leaders as well as to prepare documentary requirements for NEAP Recognition and CPD Accreditation of CPD programs.
3. Meals, venue, and accommodation relative to the conduct of the activity shall be charged to HRD-PSF 2022 Continuing Fund. For the travel expenses of the RO participants, it shall be charged to HRD-PSF 2022 Continuing Fund while for SDO participants, it shall be charged against their HRD Fund or local funds subject to usual accounting and auditing rules and regulations.
4. The first meal to be served will be breakfast on March 24, 2023, while the last meal will be dinner on March 26, 2023.
5. Enclosed are the lists of participants and evaluators for reference and guidance.
6. Writers who have not yet submitted their LRPs are enjoined to upload the soft copy in word format through: <https://bit.ly/NEAPLRPsR12> on or before **March 10, 2023**, for evaluation. On the other hand, evaluators are requested to evaluate remotely the LRPs through the same link **until March 22, 2023**. The regional focal shall communicate with the evaluators about the details of the process.
7. Identified participants of the finalization are asked to attend the **pre-work activity on March 17, 2023, via MS Teams**. The link to the meeting shall be forwarded to the participant's email addresses.
8. This Office grants two (2) days of service credits to teacher-participants as per DepEd Order No. 53, s. 2003 titled Updated Guidelines on Grant of Service Credit of Teachers, and two (2) days Compensatory Time-Off (CTO) to non-teaching participants pursuant to CSC-DBM Joint Circular No. 2, s. 2004 titled Non-Monetary Remuneration for Overtime Services.
