**FIRST QUARTER PROGRESS MONITORING AND WORKSHOP
ON THE FINALIZATION OF MADRASAH EDUCATION
PROGRAM WFP FOR CY 2023**

To: Schools Division Superintendents

1. Relevant to the program management roles and responsibilities of the regional office as stipulated in DepEd Order No. 025, s.2021, the Curriculum and Learning Management Division (CLMD) shall spearhead the First Quarter Progress Monitoring and Workshop on the Finalization of CY 2023 Work and Financial Plan (WFP) for Madrasah Education Program (MEP) on **March 7-10, 2023** (*inclusive of travel time*) at the Green Palace, Municipality of Palimbang, Sultan Kudarat.
2. The activity shall be conducted to:
 - a) monitor the implementation of Division MEP Catch-up Plans and the utilization of CY 2022 continuing funds;
 - b) finalize the draft Division MEP WFP for CY 2023;
 - c) provide technical assistance to participants in preparing activity designs for all planned activities, workshops and trainings; and
 - d) finalize the preparations for the administration of 2023 Qualifying Examination for Arabic Language and Islamic Studies (QEALIS).
3. The participants to this workshop are CLMD Chief Gilbert B. Barrera, EPS Leonardo B. Mision, EPS Regan B. Dagadas, Division MEP/ALIVE Coordinators and two school ALIVE coordinators from each SDO. The host SDO of Sultan Kudarat may identify additional participants as support staff and workshop documenters.
4. The Division MEP/ALIVE Coordinators are requested to prepare 10-minute presentation covering the following:
 - a) Implementation Report for catch-up plans utilizing the MEP Continuing Funds for CY 2022;
 - b) Updated Report on Tagging of ALIVE learners to LIS for SY 2022-2023;
 - c) List of developed curriculum resource materials and Arabic reading assessment tools;
 - d) List of qualified examinees for QEALIS 2023; and
 - e) Program implementation issues/challenges and proposed solutions.
