Steps in Complying the Google Sheet Template

Step 1: Go to <https://bit.ly/LastMileSchoolUpdatedData>.

Step 2: In column 2, determine the status of existing Last Mile School as of December 31, 2022 by indicating “Yes” or “No”.

- If the answer is “No,” there is no need to fill-out the 4th up to 7th column.
- If the answer is “Yes” but if the school has already been transferred to BARMM, just indicate “transferred to BARMM”.
- If the answer is “Yes,” indicate the following data:
 - 4th Column: Enrolment for SY 2022-2023
 - 5th Column: Email Address of the School Administrator
 - 6th Column: Name of the School Administrator
 - 7th Column: Name of the LIS Coordinator

Step 3: If in case the school has already been closed, indicate “Closed” under column 3: “Remarks”.

Step 4: Review to ensure accuracy of all entries.

Note: The data that will be gathered from the Google Sheet Template will be the official respondents of the study.
