BULLETIN OF INFORMATION

I. RATIONALE

DepEd launched the Oplan Kalusugan sa Department of Education (OK sa DepEd) which is a convergence of DepEd's health programs, plans, policies, and activities for effective and efficient implementation at the school level, in partnership with various stakeholders. OK sa DepEd focused on DepEd's major school health and nutrition programs specifically the School Based Feeding Program (SBFP), National Drug Education Program (NDEP), Adolescent Reproductive Health Education (ARH), Water, Sanitation, and Hygiene (WASH) in Schools (WinS), and Medical, Dental, and Nursing Services.

The COVID pandemic has challenged and at the same time motivated the field in being resourceful in the implementation of the OKD programs for the past two years.
