WHEREAS, the **CID-ALIVE** of the Department of Education, Schools Division of South Cotabato requested for the procurement of **Lease of Venue with meals, snacks and accommodation for the conduct of 3-day Training on 2nd Quarter Madrasah Education Program Implementation Review cum Progress Monitoring Workshop on July 5-7, 2023 (Live-In)** (DSC-23-06-084) with the approved budget for the contract (ABC) amounting to **One Hundred Forty-Eight Thousand Eight Hundred Pesos (Php 148,800.00)**;

WHEREAS, the Schools Division Superintendent approved the conduct of such activity which requires leasing of venue including meals and snacks;

WHEREAS, Section 53.10 of the Revised implementing Rules and Regulations (IRR) of RA 9184 allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue for official use;

WHEREAS, the BAC received only one (1) quotation and opened the same on June 30, 2023, 10:00 am;
