WHEREAS, the CID-ALIVE of the Department of Education, Schools Division of South Cotabato requested for the procurement of Lease of Venue with meals, snacks and accommodation for the conduct of 3-day Training on 2nd Quarter Madrasah Education Program Implementation Review cum Progress Monitoring Workshop on July 5-7, 2023 (Live-In) (DSC-23-06-084) with the approved budget for the contract (ABC) amounting to One Hundred Forty-Eight Thousand Eight Hundred Pesos (Php 148,800.00);
