WHEREAS, the Supply office of the Department of Education, Schools Division of South Cotabato requested for the procurement of **Supply and Delivery of Toner TN118 (DSC-23-10-132)** with the approved budget for the contract (ABC) amounting to **Twenty Thousand Six Hundred Twenty-Five Pesos (PhP 20,625.00)**;

WHEREAS, the proponent of the project presented documents and informed the Bids and Awards Committee that said items can only be procured from the exclusive distributor, **Copylandia Office Systems Corporation** with office address at Door 3-D Juduta Bldg., Catolico Ave., General Santos City;

WHEREAS, the BAC, upon careful deliberation and evaluation of the presented documents determined that the aforementioned project be procured through Direct Contracting since **Copylandia Office Systems Corporation**. is the exclusive distributor;

WHEREAS, Section 50 of Republic Act No. 9184, allows the procurement of the following:

- a) Procurement of Goods of proprietary nature which can be obtained only from the proprietary source, i.e. when patents, trade secrets, and copyrights prohibit others from manufacturing the same item;
- b) When the procurement of critical components from a specific supplier is a condition precedent to hold a contractor to guarantee its project performance, in accordance with the provisions of its contract; or
- c) Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GoP.

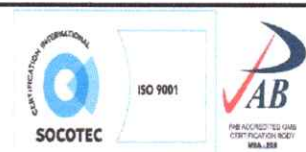
WHEREAS, the BAC thru its Secretariat requested **Copylandia Office Systems Corporation**, to submit quotation and documentary requirements;


