A RESOLUTION TO AWARD THE LEASE OF VENUE WITH MEALS AND ACCOMMODATION TO NEAP REGION XII AS THE SERVICE PROVIDER THROUGH NP-AGENCY-TO-AGENCY AND RECOMMENDING FOR THE APPROVAL OF THE HEAD OF THE PROCURING ENTITY (HOPE)

RESOLUTION NO.: 2023-10-057

WHEREAS, the Department of Education, Schools Division of South Cotabato, CID-IPED requested for the procurement of **Lease of venue with meals and accommodation for the conduct of Orientation on Teachers, School Heads and Supervisors on Indigenous People’s Program on November 10-13, 2023** (DSC-23-10-140) with the approved budget for the contract (ABC) amounting to **Three Hundred Seventy-Five Thousand Pesos (Php 375,000.00)**;

WHEREAS, the BAC issued **Resolution No. 2023-10-056**, recommending the alternative method of procurement – negotiated procurement agency-agency;

WHEREAS, pursuant to Sec. 53.5 Negotiated Procurement - Agency-To-Agency of the IRR of RA No. 9184, is an alternative method of procurement with the **general policy of government to purchase its requirements from the private sector**. However, it acknowledges that, in some exceptional cases, procurement from another agency of the government is more efficient and economical for the government, subject to the following conditions: **i. The Procuring Entity shall justify that entering into an Agency-to-Agency Agreement with the Servicing Agency is more efficient and economical to the government;**

WHEREAS, on October 23, 2023, BAC allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue through alternative method of procurement agency-to-agency;

WHEREAS, the BAC, upon careful deliberation and evaluation, found **NEAP ROXII** eligible and compliant with requirements as the service provider through negotiated procurement agency-to-agency detailed as follows;


