WHEREAS, the Department of Education, Schools Division of South Cotabato, SGOD-HRD requested for the procurement of **Lease of Venue with Meals, Snacks and Accommodation for the conduct of 2-Day HRRD-HRDS Q4 Program Implementation Review on December 6-7, 2023** (DSC-23-11-155) with the approved budget for the contract (ABC) amounting to **One Hundred Fifty-Nine Thousand Pesos (Php 159,000.00)**;

WHEREAS, the Schools Division Superintendent approved the conduct of such activity which requires leasing of venue including meals, snacks and accommodation;

WHEREAS, Section 53.10 of the Revised implementing Rules and Regulations (IRR) of RA 9184 allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue for official use;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat invited three (3) hotels/venues of known qualifications to submit quotations;

WHEREAS, the BAC received three (3) quotations and opened the same on November 22, 2023, 10:00 am;

WHEREAS, the BAC, upon careful deliberation and evaluation of the submitted price quotation and compliant with the requirements, found the offer of **The Farm at Carpenter Hill, Inc.** as the service provider with the lowest calculated and responsive quotation detailed as follows;


