A RESOLUTION TO AWARD THE LEASE OF VENUE WITH MEALS, SNACKS AND ACCOMMODATION FOR THE CONDUCT OF COACHING AND MONITORING PROGRAM FOR NQESH ASPIRING SCHOOL HEADS TO SA BALAI LAKE VIEW RESORT AS THE SERVICE PROVIDER WITH THE SINGLE CALCULATED AND RESPONSIVE QUOTATION (SCRQ) AND RECOMMENDING FOR THE APPROVAL OF THE HEAD OF THE PROCURING ENTITY (HOPE)

WHEREAS, the Department of Education, Schools Division of South Cotabato, SGOD-HRD, requested for the procurement of **Lease of Venue with Meals, Snacks and Accommodation for the conduct of Coaching and Monitoring Program for NQESH Aspiring School Heads on December 1-2, 2023 (Live-In)** (DSC-23-11-166) with the approved budget for the contract (ABC) amounting to **One Hundred Twenty Thousand Pesos (Php 120,000.00)**;

WHEREAS, the Schools Division Superintendent approved the conduct of such activity which requires leasing of venue including accommodation, meals and snacks;

WHEREAS, Section 53.10 of the Revised implementing Rules and Regulations (IRR) of RA 9184 allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue for official use;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat invited three (3) hotels/venues of known qualifications to submit quotations;

WHEREAS, the BAC received only one (1) quotation and opened the same on November 22, 2023, 10:00 am;

WHEREAS, the BAC, upon careful deliberation and evaluation of the submitted price quotation and compliant with the requirements, found the offer of **Sa Balai Lake View Resort** as the single calculated and responsive quotation detailed as follows;


