A RESOLUTION TO RECOMMEND AND AWARD THE LEASE OF VENUE WITH MEALS AND ACCOMMODATION TO NEAP REGION XII AS THE SERVICE PROVIDER THROUGH NP-AGENCY-TO-AGENCY AND RECOMMENDING FOR THE APPROVAL OF THE HEAD OF THE PROCURING ENTITY (HOPE)

WHEREAS, the Department of Education, Schools Division of South Cotabato, OSDS-Accounting, requested for the procurement of **Lease of venue with meals and accommodation for the conduct of Seminar-Workshop of Clustered Finance Personnel on Accounting of School Financial Transactions on December 4-5, 2023** (DSC-23-11-172) with the approved budget for the contract (ABC) amounting to **One Hundred Seventy-Four Thousand Pesos (Php 174,000.00)**;

WHEREAS, pursuant to Sec. 53.5 Negotiated Procurement - Agency-To-Agency of the IRR of RA No. 9184, is an alternative method of procurement with the **general policy of government to purchase its requirements from the private sector. However, it acknowledges that, in some exceptional cases, procurement from another agency of the government is more efficient and economical for the government, subject to the following conditions: i. The Procuring Entity shall justify that entering into an Agency-to-Agency Agreement with the Servicing Agency is more efficient and economical to the government;**

WHEREAS, on November 21, 2023, BAC allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue through alternative method of procurement agency-to-agency;

WHEREAS, the BAC, upon careful deliberation and evaluation, found **NEAP ROXII** eligible and compliant with requirements as the service provider through negotiated procurement agency-to-agency detailed as follows;
