**WHEREAS**, the Department of Education, Schools Division of South Cotabato, OSDS-Accounting Office requested for the procurement of **Lease of Venue with Meals and Snacks for the conduct of Seminar-Workshop on Clustered Finance Personnel on Accounting of School Financial Transactions on December 23, 2023** (DSC-23-12-187) with the approved budget for the contract (ABC) amounting to **One Hundred Twenty-Two Thousand Pesos (Php 122,000.00)**;

**WHEREAS**, the Schools Division Superintendent approved the conduct of such activity which requires leasing of venue including accommodation, meals and snacks;

**WHEREAS**, Section 53.10 of the Revised implementing Rules and Regulations (IRR) of RA 9184 allows the procuring entities to resort to negotiated procurement for leasing a privately-owned venue for official use;
