**PLANNING CONFERENCE ON CURRICULUM MANAGEMENT AND LEARNING
DELIVERY WITH ENGLISH SUPERVISORS**

To: Schools Division Superintendents
Division Education Program Supervisors in English

1. To provide enabling support in the implementation of the English Curriculum and Learning Delivery, this office through the Curriculum and Learning Management Division (CLMD) shall conduct a **Planning Conference on Curriculum Management and Learning Delivery in English on February 28-29, 2024**, within South Cotabato. The specific venue will be announced through a separate issuance.
2. The activity shall be conducted purposely to:
 - a) monitor progress and assess the implementation of the Curriculum and Learning Delivery in English;
 - b) analyze data on the least-learned competencies in Key Stages 2-4;
 - c) discuss the results of the National Achievement Test (NAT) in English;
 - d) provide technical support to Division Education Program Supervisors in the implementation of English Curriculum and Learning Delivery; and
 - e) provide updates on the policy and strategic direction of the learning delivery programs including the professional development opportunities for English and Language teachers.
3. Enjoined to attend from the Regional Office are the CLMD Chief and Education Program Supervisor in English, while from Schools Division Offices are the Education Program Supervisors in English. See Enclosure 1 for the Schedule of Activities and Enclosure 2 for the List of Participants.
