**CONDUCT OF ANTI-ONLINE SEXUAL ABUSE AND EXPLOITATION OF
CHILDREN (OSAEC) AND ANTI-CHILD SEXUAL ABUSE OR
EXPLOITATION MATERIALS (CSAEM)
CLASSROOM-BASED SESSION**

To: Schools Division Superintendents
All Others Concerned

1. This has reference to the Joint Memorandum from the Office of the Undersecretary for Curriculum and Teaching and Undersecretary for Operations through the Learner Rights and Protection Office (LRPO) dated January 8, 2024 regarding the conduct of a classroom based learning session for the awareness of the Anti-Online Sexual Abuse and Exploitation of Children (OSAEC) and Anti-Child Sexual Abuse or Exploitation Materials (CSAEM) policy in schools in partnership with the Stairway Foundation, Inc. (SFI).

2. In compliance with Presidential Proclamation No. 417 “Declaring the Second Tuesday of February of Every Year as Safer Internet Day for Children in the Philippines and in line with the promulgation of the Implementing Rules and Regulation (IRR) of Republic Act No. 11930: “An Act Punishing Online Sexual Abuse or Exploitation of Children, Penalizing the Production, Distribution, Possession and Access of Child Sexual Abuse or Exploitation Material (CSAEM), the classroom-based learning session shall be conducted.

3. The session shall be conducted by **classroom advisers** during their Homeroom subject on any day of February in time with the observance of the Safer Internet Day Philippines. The presentation along with its guide script and session guide can be accessed through this link:

4. Relative to this, a national orientation will be held on **February 13, 2024** for the teachers, educators, non-teaching / support personnel parents and stakeholders via Facebook live through DepEd official Facebook Page.

5. For **monitoring and evaluation, class advisers** shall submit to the school head the list of attendees of the classroom-based session including the number of reported disclosures, if any, using the template enclosed as **Annex A**.

The school head shall consolidate the data (*number of attendees per grade level*) with the assistance of the school’s Guidance Counselor or Administrative Personnel (in compliance with DO No. 2, s. 2024 or the Immediate Removal of Administrative Tasks of Public School Teachers) using the template enclosed as
