# PPRD's ACCOUNTABILITY MECHANISM IN THE QMS OPERATIONALIZATION AT RO & SDO LEVELS

To: Schools Division Superintendents RFD Chiefs

- 1. This has reference to the QMS Operation Manual Revision 2 as of January 9, 2024 of Policy, Planning & Research Division (PPRD) which includes five (5) processes: Plan Formulation, Policy Development (Implementation & Review), Data Information Management, and Performance Monitoring & Evaluation. For the full operationalization of these QMS processes, PPRD has instituted an Accountability Mechanism to ensure clear strategic directions among its personnel, Regional Functional Division (RFD) partners and School Division Office (SDO) counterparts.
- 2. This **Accountability Mechanism** aims to:
  - a. provide PPRD personnel clear accountability in the provision of technical assistance, follow-up, and monitoring as regards compliance of its deliverables through the data inputs and/or reports of its RFD partners and SDO counterparts;
  - b. ensure that all RFD partners and SDO counterparts can comply in submitting required data inputs and/or reports on the expected time frame; and
  - c. foster strong partnership and collaboration in the full institutionalization of PPRD's QMS processes and as mechanism of providing TA to all its SDO counterparts as regards operationalization of such QMS processes as well at the division level.
