ADMINISTRATION OF THE NATIONAL LEARNING CAMP ASSESSMENT (NLCA) 2024

To: Schools Division Superintendents

- 1. This is in reference to DM-CT-2024-040 that announces the conduct of the National Learning Camp Assessment (NLCA) for Grades 7 to 10 public school learners through the Bureau of Educational Assessment (BEA).
- 2. The administration of NLCA shall determine the effectiveness of the learning camp intervention on the learning proficiencies of participating learners before and after attending the National Learning Camp (NLC).
- 3. The assessment will be computer-based and shall cover learning areas in English, Science, and Mathematics. Each test item will measure varying levels of skills and competencies in a multiple-choice format using the English language.
- 4. The NLCA shall be administered on the following dates:

Grade Level	Activity	Testing Window
7 and 8	Pre-test	March 11-April 12, 2024
9 and 10		April 15-May 17, 2024

- 5. The Schools Division Offices (SDOs), through DTCs and DITOs, shall ensure that all public secondary school learners have activated their Microsoft Accounts and have accessed the Regional Learning Management System (LMS).
- 6. Moreover, this office also requests the SDOs to submit the consolidated list of NLCA Testing Centers. The template for the NLCA 2024 consolidated list of testing centers can be accessed at https://bit.ly/NLCA2024TestingCenter, and shall be uploaded through https://forms.office.com/r/KFnM1YzRYQ on or before March 1, 2024.
