**2024 OPLAN KALUSUGAN SA DEPED – HEALTHY LEARNING INSTITUTIONS
(OKD-HLI) ONBOARDING WORKSHOP**

To: Schools Division Superintendents

1. The Department of Education (DepEd) through the Bureau of Learner Support Services-School Health Division (BLSS-SHD) continues to **enjoin all offices and schools concerned to strongly support and actively participate in the activities related to the implementation of Healthy Learning Institutions (HLI) in DepEd.**
2. The 2022 OKD-HLI Pilot of Region SOCCSKSARGEN, SDO Sultan Kudarat, ended in 2023 and the 2024 HLI expansion site was identified to be in **SDO South Cotabato.**
3. **Onboarding workshops for the Local School and Health Boards** have been streamlined for the 2024 expansion sites and will start on **March 18-22, 2024** in a venue within Metro Manila that will be announced later through an Advisory from the Bureau of Learner Support Services (BLSS).
4. The workshop provides an opportunity for the DOH-CHDs and DepEd ROs to initiate discussions regarding HLI which they can continue when they return to their respective workstations.

8. The Department of Health (DOH) shall cover the board and lodging of DepEd participants whereas travel expenses shall be charged to local funds, subject to the usual accounting and auditing rules and regulations.
