TECHNICAL WORKING GROUP ON THE CONDUCT OF COMPARATIVE ASSESSMENT ON PPST NON-CLASSROOM OBSERVABLE INDICATORS (NCOI) THROUGH TEACHERS REFLECTION FORM (TRF) FOR TEACHER I APPLICANTS

To: Assistant Schools Division Superintendent Public Schools District Supervisors/Principals In-Charge Public Elementary and Secondary School Heads All Others Concerned

1. In reference to Division Memorandum OSDS No. 26 s. 2024 on the **Recruitment and Selection Process for Elementary, Junior High School and Senior High School Teacher I Applicants,** division hereby designates the District/Municipal Subcommittee, proctors, and technical working committee to assist the HRMPSB in conducting the comparative assessment, specifically on the Non-Classroom Observable Indicators (NCOI) through Reflection Form (TRF) on May 5, 2024 and the checking of TRF will be carried out on May 7-8, 2024.

2. The Following shall be the duties and responsibilities

a. Assist the HRMPSB in conducting the comparative assessment on NCOI through the Teacher Reflection Form for elementary, Junior High School, and Senior High School teacher-I applicants;

b. Ensures compliance with all provisions of DepEd Order No. 007, s. 2023, specifically item number 7 of Enclosure No. 02: PPST Non-Classroom Observable Indicators (NCOI);

- c. Ensure seamless conduct of TRF of teacher applicants through:
 - i. Communication with the applicants regarding the schedule of the TRF through the HRMPSB Secretariat Subcommittee or the Administrative Officer II;
 - ii. Building Supervisors will be responsible in monitoring the room assignments for Teacher I applicants;
 - iii. A proctor and secretariat will be assigned to discuss the instructions and oversee the TRF process;

- iv. A complete set of classroom observation tools, as stipulated in DepEd Order No. 007, s. 2023 such as the Teacher Reflection Form (TRF), will be prepared; and
- v. Results of PPST-NCOI will be consolidated and submitted to the HRMPSB in coordination with the HRMPSB Secretariat Subcommittee or the Administrative Officer II.

3. The designated proctors will administer the NCOI exam On May 05, 2024, at Libertad NHS and Tupi NHS. The evaluation/checking of the TRF will be conducted on May 7-8, 2024, by the Subcommittee's TRF evaluators at the SDO Conference Hall, Koronadal City.

4. Please be informed, that as per DepEd Order 007, s. 2023 entitled "Guidelines on Recruitment, Selection, and Appointment in the Department of Education", the Head of the Office may designate subcommittees in the school, districts, or offices, as deemed practicable, to assist the HRMPSB in the process of comparative assessment and perform functions as defined by the HRMPSB and shall maintain full responsibility and accountability in the results of the comparative assessment, and therefore, shall be responsible for queries and complaints pertaining to the comparative assessment.

5. Enclosed are the list of HRMPSB district/municipal subcommittee members assigned as TRF evaluators as well as the roaster of proctors and technical working committee.

6. Food and travel expenses of the Subcommittees and Administrative Officers II shall be chargeable against School/Division MOOE and other local funds, subject to the usual accounting and auditing rules and regulations.

7. For services rendered on Holidays, Saturday and Sunday, all concerned teachers and personnel are entitled to Compensatory Time-off (CTO) or service credits in accordance with Civil Service and DBM Joint Circular No. 2, s, 2004 on Non-Monetary Remuneration for Overtime Service Rendered, or DO 53, s. 2003 on Updated Guidelines on Grant of Vacation Service Credits to Teachers.
